Sikh Academy Trust (SAT) meeting with Khalsa Secondary Academy Staff at KSA

In attendance:

Khalsa Secondary Academy – Introduction from Simon Webb (Interim CEO for KAT). All KAT staff left the meeting after the introduction.

RSV introduced SAT and those in attendance from the SAT Board. The objective of the meeting was to provide confidence and reassurance in the future for parents, children and KSA.

Jujar Singh then introduced himself and said Sikh Academies Trust is a new Academy Trust formed to manage KPS which was converted into an academy and joined SAT on 1st February 2021. Khalsa Primary School (KPS) were re-rated OUTSTANDING in the new framework in January 2020. Trustees of SAT have a wide range of experiences, HR, Finance, Educational, Legal, Business, Banking, STEM education.

Following the DFE's decision to terminate the funding to KAT last year, SAT was chosen as the preferred Trust to take over KSA. SAT have had a productive meeting with KAT and are working together to ensure a smooth transition of KSA to SAT. The due diligence process will be commencing soon.

RSV discussed his experience which included his 8th headship, with 2 headships of 3 - 18 schools. He also mentioned that he was Director of Education of 12 schools of which two were secondary schools. He went on to cover:

SAT's Vision – We help to develop our pupils to become exemplary British Citizens. We foster a stimulating and challenging environment. All members of the school community are respected, motivated and prepared for the challenging world in which we live.

SAT's Values – these are based on Compassion, Truth, Humility, Love and Contentment.

SAT is aware that the teaching and learning at KSA is good. Teachers are very dedicated and supportive. SAT believe this can be further developed and give you the confidence to take yourselves and the school further.

KSA has may strengths including the teaching & learning by the great staff and SAT wants to use those strengths as we go forward. The immediate priorities are safeguarding, SEND and capacity building.

SAT's aim is to move KSA to OUTSTANDING in 4 years. This can only happen if everyone works together with a shared vision. Emotional Health and Wellbeing is the highest priority for SAT.

Two members of the KPS SLT gave a brief account of their experiences of being staff members at KPS.

What is SAT's experience with secondary schools	RSV mentioned he has worked in 3 different schools from 3-18.

	SAT have trustee on the SAT board who is secondary school experienced head. In addition, SAT will be using expertise from Upton Grammar School.
Will there be a site change for KSA	Externally the building for KSA is OK, but internally there may be some changes required, to make it more child friendly. At this stage there is no intention of relocating. In addition, a significant change such as this would require a consultation amongst other considerations.
KSA currently have teams to support HR, SENDCo, Safeguarding. What are plans for SAT?	At the moment it is perceived that for 2 schools, SAT would require: • Finance Director for 2-3 days • CEO for 2-3 days • Safeguarding - full time • HR, SENDCo will likely be done inhouse.
How will the Mental Health of students be considered?	It was noted that there was a counsellor on site and there would be discussion with them to ensure mental health of student is being considered. Gurdwara time is also important for children's mental wellbeing, so it is important for this to be incorporated into the school's daily routine.
There is no bursar/HR on site	At KPS, we use Strictly Education as our HR Provider and they will be will be supporting both schools.
Staff room is too small	RSV was surprised to see the size of the staff room. SAT intend to look at relocation after transfer.
Will the CCF Army provision continue?	Yes this will continue. This is a fantastic provision and good for the children.
Will there be a change to curriculum	If there are any changes, this will only happen once staff suggestions have been considered, because it's about teamwork. Nothing will be changed unnecessarily. Curriculum at KSA should be broad and balanced.
Are SAT are affiliated with AKJ and what maryada will be followed at KSA?	Slough Sikh School Trust follows the Akal Takhat Sahib Rehat Maryada and have always done so at KPS. This is on the KPS school website and policies. Staff said that's not what they were told.

	The SSST and the Trustee board are made up of a number of different Trustees/Members from all different backgrounds and affiliations but when it comes to SAT, these affiliations are secondary and the schools follow the Sikh Code of Conduct from Sri Akal Takht Sahib.
How will the CEO listen to staff	RSV (the CEO) will sit with all the teams including admin. Doesn't matter what role anyone plays – every role deserves to be heard.
